ITEM 1 - AD#3: To the Project Manual, Section 00100, NOTICE TO SUB-CONTRACTORS AND MATERIAL SUPPLIERS, REQUEST FOR COMPETITIVE SEALED PROPOSALS, and Section 00200, NOTICE TO PROPOSERS FOR SEALED PROPOSALS FOR SUB-CONTRACTORS AND MATERIAL SUPPLIERS.

DELETE: The deadline for Proposals being received of August 17, 2017 at 2:00 p.m.

ADD: The deadline for Proposals being received shall be Tuesday, August 22, 2017 at 2:00 p.m.

ITEM 2 - AD#3: To the Project Manual, Section 095113, ACOUSTICAL PANEL CEILINGS.

<u>DELETE</u>: On page **095113-6** under part **3.5(A)**, the indication of "Beveled Tegular" edge detail and ¾" thickness. <u>ADD</u>: The specified ceiling tile shall be square edge, 5/8" thickness.

ITEM 3 - AD#3: To the Project Manual, Section 092550, GYPSUM BOARD ASSEMBLIES.

<u>ADD</u>: As clarification, Hi-Impact (vandal-resistant) gypsum board shall be used in Corridor areas only unless Fire-Resistant gypsum board is required. All other locations shall have regular-type gypsum board, again unless Fire-Resistant gypsum board is required in a particular application. As further clarification, at locations of ceramic wall tile, cement backer board shall be used as specified in Section **092813**, **CEMENT BACKER BOARD**.

ITEM 4 - AD#3: To the Project Manual, Section 099900, FINISH SCHEDULE.

<u>ADD</u>: As clarification, ceiling heights vary in each space/building and will need to be field verified. For bidding purposes, ceiling heights shall generally be as follows: <u>Classrooms, Offices, Corridors, and Misc. spaces</u>: **9'-0"**; Lecture Halls: **12'-0"**.

<u>ADD</u>: A Unit Price for painting (prep and application of coats as specified) per square foot, when <u>added</u> and <u>deducted</u>.

<u>ITEM 5 - AD#3</u>: To the Project Manual, Section **012300**, <u>ALTERNATES</u>; and Section **099900**, <u>FINISH SCHEDULE</u>; and the Drawings, "**Demolition Plans**".

ADD: The **Base Bid** shall include patching the existing ceramic floor and wall tile (to match existing) in the following Buildings & spaces: **Ferguson Building**: "Women 3RR1" and "Men 3RR2"; **Fain Fine Arts**: "Women 1RR1" and "Men 1RR2"; and the **Hardin Administration Building**: "Toilet 1RR5" and "Toilet 1RR6".

<u>ADD</u>: The <u>Base Bid</u> shall include patching the existing vinyl wall covering (to match existing) in the following Building & spaces: <u>Fain Fine Arts</u>: "Women 1RR5" and "Men 1RR6".

<u>ADD</u>: <u>Alternate #5</u> which shall include the removal of the existing floor and wall finishes (ceramic tile or vinyl wall covering) and provide new ceramic floor and wall tile in the following Buildings & spaces: <u>Ferguson Building</u>: "Women 3RR1" and "Men 3RR2"; <u>Fain Fine Arts</u>: "Women 1RR1", "Men 1RR2", "Women 1RR5" and "Men 1RR6"; and the Hardin Administration Building: "Toilet 1RR5" and "Toilet 1RR6".

<u>ITEM 6 - AD#3</u>: To Plumbing Drawings, Sheet "P003", "Plumbing Fixture Schedule"; and the Project Manual, Section 224213.13, COMMERCIAL WATER CLOSETS.

<u>ADD</u>: As clarification, the Water Closets shall be wall-mounted fixtures as specified in the "**Plumbing Fixture Schedule**".
